## **Remote Participation and Voting**

1. In view of the COVID-19 health concerns, the 10th AGM of the Company will be conducted fully virtual via live streaming and online remote voting using the Remote Participation and Voting facilities ("RPV").

Our Company has appointed Tricor Investor & Issuing House Services Sdn. Bhd. ("**Tricor**") as our poll administrator for the 10th AGM to facilitate the RPV via TIIH Online website at https://tiih.online.

2. The Broadcast Venue above is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairperson of the meeting to be present at the main venue of the meeting.

Members or proxies or authorised representatives or attorneys **WILL NOT BE ALLOWED** to be physically present at the Broadcast Venue on the day of the 10th AGM.

- 3. Only members whose names appear in the **Record of Depositors as at 13 November 2020** shall be entitled to participate and vote remotely at the 10th AGM or appoint proxy to participate and vote on his/her behalf.
- 4. Members who wish to participate and vote at the 10th AGM remotely via the RPV are required to register for RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> in accordance with the procedures set out in the Administrative Guide for AGM which is available on <a href="http://www.inariberhad.com/2020-10th-annual-general-meeting.asp">http://www.inariberhad.com/2020-10th-annual-general-meeting.asp</a>.
- 5. If you wish to appoint a proxy to participate and vote on your behalf at the 10th AGM via the RPV, you may deposit your original Proxy Form with Tricor at :

A member who has appointed a proxy or authorised representative or attorney to participate in the 10th AGM via RPV must request his/her proxy or authorised representative or attorney to register himself/herself for RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> in accordance with the procedures set out in the Administrative Guide.
