Remote Participation and Voting

1. The EGM of the Company will be conducted fully virtual via live streaming and online remote voting using the Remote Participation and Voting facilities ("**RPV**").

Our Company has appointed Tricor Investor & Issuing House Services Sdn. Bhd. ("**Tricor**") as our poll administrator for the EGM to facilitate the RPV via TIIH Online website at <u>https://tiih.online</u>.

- Only members whose names appear in the Record of Depositors as at 14 November 2022 shall be entitled to participate and vote remotely at the EGM or appoint proxy to participate and vote on his/her behalf.
- 3. Members who wish to participate and vote at the EGM remotely via the RPV are required to register for RPV at TIIH Online website at <u>https://tiih.online</u> in accordance with the procedures set out in the Administrative Guide for EGM which is available on <u>https://www.inari-amertron.com/2022-12th-agm.asp</u>.
